Illinois Fertilizer and Chemical Association is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Illinois Fertilizer and Chemical Association Web site and governs data collection and usage. By using the Illinois Fertilizer and Chemical Association website, you consent to the data practices described in this statement.

#### Collection of your Personal Information

Illinois Fertilizer and Chemical Association collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Illinois Fertilizer and Chemical Association also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Illinois Fertilizer and Chemical Association. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Illinois Fertilizer and Chemical Association for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Illinois Fertilizer and Chemical Association Web site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Illinois Fertilizer and Chemical Association public message boards, this information may be collected and used by others. Note: Illinois Fertilizer and Chemical Association does not read any of your private online communications.

#### Use of your Personal Information

Illinois Fertilizer and Chemical Association collects and uses your personal information to operate the Illinois Fertilizer and Chemical Association Web site and deliver the services you have requested. Illinois Fertilizer and Chemical Association also uses your personally identifiable information to inform you of other products or services available from Illinois Fertilizer and Chemical Association and its affiliates. Illinois Fertilizer and Chemical Association may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Illinois Fertilizer and Chemical Association does not sell, rent or lease its customer lists to third parties. Illinois Fertilizer and Chemical Association may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Illinois Fertilizer and Chemical Association may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Illinois Fertilizer and Chemical Association, and they are required to maintain the confidentiality of your information.

Illinois Fertilizer and Chemical Association does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Illinois Fertilizer and Chemical Association keeps track of the Web sites and pages our customers visit within Illinois Fertilizer and Chemical Association, in order to determine what Illinois Fertilizer and Chemical Association services are the most popular. This data is used to deliver customized content and advertising within Illinois Fertilizer and Chemical Association to customers whose behavior indicates that they are interested in a particular subject area.

### Use of Cookies

The Illinois Fertilizer and Chemical Association Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Illinois Fertilizer and Chemical Association pages, or register with Illinois Fertilizer and Chemical Association site or services, a cookie helps Illinois Fertilizer and Chemical Association to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. ### Security of your Personal Information
