\$50.6B STATE BUDGET HEADS TO GOVERNOR'S DESK

Illinois lawmakers finally approved a new state budget early Saturday, sending it to Democratic Gov. JB Pritzker for his signature with just over a month to spare before it takes effect with the new state fiscal year July 1. The House approved the \$50.5 billion spending plan on a 73-38 vote just after 2:30 a.m. Saturday after it passed the Illinois Senate 34-22 early Friday.




ILLINOIS STATE BUDGET EXPANDS MEDICAID

The legislative session in Springfield was extended as legislators try to reconcile the cost of health benefits for qualifying residents regardless of immigration status. Democrats hold a supermajority in the statehouse.



SENATE AND HOUSE PASS TAX EXEMPTION FOR ETHANOL



The Illinois Senate passed a revenue package Wednesday containing a number of tax credits and exemptions. This was a major boost for the corn industry in Illinois by increasing the level of ethanol in fuel to be eligible for a fuel sales tax exemption.

SB 1963 passed both chambers with bipartisan support and heads to the governor's desk.



IFCA had another successful year at the Illinois state capitol this spring session.

We were able to hold off any harmful legislation that might directly affect the industry negatively. Following are some of the most important legislations that IFCA was monitoring this spring session. A total of 6,689 pieces of legislation were introduced in both the House and Senate this spring, 565 passed both chambers.


